General Conditions:

1. The Applicant shall pay DC, PC and other charges within 30 days.
2. The applicant shall comply the conditions laid down in the G.O.Ms.No.168, dt.7-4-2012 & its amendments and NBC.
3. The applicant shall form BT road before release of Occupancy Certificate from HMDA.
4. The applicant shall submit an undertaking in terms of G.O. Ms. No. 541 MA, dt.17.11.2000.
5. The applicant shall follow the conditions imposed by HMDA misinterpretation or suppression of any material facts or rule.
6. The applicant / developer is the whole responsible if any loss of human life or any damage occurs while constructing the building and after construction of building and have no rights to claim and HMDA and its employees shall not be held as a party to any such dispute/ litigations
7. The applicant is the whole responsible if any discrepancy occurs in the ownership documents and ULC aspects and if any litigation occurs, the technically approved building plans may be with-drawn without any notice.
8. The applicant/ developer are the whole responsible if anything happens/ while constructing the building.
9. If any cases are pending in court of law with regard to the site U/R and have adverse orders, the permission granted shall deem to be withdrawn and cancelled.
10. The applicant shall provide the STP and septic tank as per standard specification.
11. Any conditions laid by the authority are applicable.
12. The Owner/Developers shall be responsible for the safety of construction workers.
13. If in case above said condition are not adhered HMDA/Local Authority can withdraw the said permission.
14. The HMWS and SB and T.S Transco not to provide the permanent connection till to produce the occupancy certificate from the Sanctioning Authority.
15. The applicant shall pay complying to conditions and fee shall be paid within 30 days from the date of Fee intimation letter. If the fee is not paid within 30 days then interest @12% per annum shall be charged for the delay period.

Fees Intimation Conditions:

1. That the applicant shall comply the conditions laid down.
2. This permission does not bar any public agency including HMDA/Local Body to acquire the lands for public purpose as per Law.
3. The applicant shall mortgage 10% of the built up area in the ground floor or first floor or the second floor, as the case may be, to the sanctioning authority by the way of registered mortgage in favor MC , HMDA as per G.O.Ms.No. 168 M.A, dt 07.04.2012

Further action for release of approvals will be taken after fulfilling the above conditions, if the fee and undertakings are not submitted within the stipulated time, your application will be Auto closed without any further intimation.

This shall not be construed as approval of the proposal and permission for development.

2. FSID charges to be paid ONLINE through DPMS using CREDIT CARD/ DEBIT CARD / NET BANKING.
